I have read, understood and agreed to all the terms and conditions on this form. I accept full financial responsibility for the equipment listed on this form and promise to return it clean and undamaged. If I fail to do so, I agree to pay for its replacement at the full price, as determined by the rental shop as well as full rental value of any additional day lost. I understand and agree that skiing, snowboarding, tubing, and related activities are **HAZARDOUS and that injuries are common and ordinary** occurrences during these activities. **I AGREE FOR MYSELF, MY CHILD OR WARD TO ASSUME ALL RISKS OF INJURY OR DEATH** which may result from these activities. I understand that no headgear can protect against all foreseeable impacts, that skiing, snowboarding, and tubing can expose the user to forces which exceed the limits of protection offered by this helmet, that helmets do not guard against injury to the neck, spine, face or any other part of the body, and that these features are inherent risks of using this equipment.
